The school board would like to congratulate all the 2019-2020 Graduating Seniors!

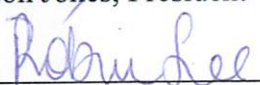
Following the board member input segment, the meeting adjourned at 5:49 p.m. The motion was made by Nathan, seconded by Robin, all voted to approve.
