The motion was made by Eleanor, seconded by Jason, all voted to approve.

The board approved the recommendations to hire Linda Foster as elementary Para-Professional, and Sydney Davis as high school para-professional and JR/SR Cheerleading Sponsor for the 2020-2021 school year. The motion was made by Eleanor, seconded by Robin, all voted to approve.

The board did give great big THANK YOU to all the administration and staff for all the hard work and communication during this difficult time for everyone.
