Minutes of Regular Meeting

April 10, 2023

The meeting was called to order at 5:30 p.m. with the following members present: Eleanor Davenport, Robin Lee, Travis Doshier Nathan Rogers and Jason Jones.

The meeting opened with the Pledge of Allegiance.

The board approved the resignation from Jessica McKinney as para professional for the 2023-2024 school year. The motion was made by Jason, seconded by Travis, all voted to approve.

The board approved the recommendation to hire Bridgett Edwards as High School Secondary Science Teacher for the 2023-2024 school year. The motion was made by Travis, seconded by Nathan, all voted to approve.




