SUPERINTENDENT'S CONTRACT

PARTIES: The Yellville-Summit School District, Party of the First Part and Wesley Henderson, Party of the Second Part, agree as follows:

EMPLOYMENT: The Party of the First Part by a majority vote of the School Board present at a legally held meeting on January 9, 2023 agrees to employ Wesley Henderson, Party of the Second Part, as provided herein:

SERVICE: Party of the Second Part agrees to perform services as follows: *SUPERINTENDENT OF SCHOOLS*
Additional Duty:

These services will be rendered in accordance with the policies set forth by the Party of the First Part. Compensation has been included in the total contract amount for all of the above services. Any change in services may result in a reduction of or an addition to the total compensation under this contract.

TIME: The time period covered by this contract is 480 days, from July 1, 2022 through June 30, 2025.

COMPENSATION FOR SERVICES: Total compensation under this contract is \$211054.40 to be paid in 24 installments.

Furthermore, the Party of the First Part is authorized to make legally required deductions from the compensation herein stated. Manual calculations of the above stated compensation may vary by cents. In this event, the amount stated above shall govern.

BOARD POLICIES: The personnel policies of each school district in effect at the time a teacher's contract is entered into or renewed shall be considered to be incorporated as terms of said contract and shall be binding upon both parties unless policy change is to bring the district policies into compliance with a change in Arkansas or Federal law or regulation and is adopted within ninety (90) days from the effective date of the change in the law or regulation. (Act 835 of 2015)

CERTIFICATION: The Party of the Second Part certifies that, at the date of this contract, he or she is not under employment contract with another school district.

REFUND OF UNEARNED COMPENSATION: The Party of the Second Part agrees to refund the Party of the First Part any compensation received for which no services were rendered


TERMINATION: This contract may be terminated by either party pursuant to law.

OTHER CONDITIONS: Other duties as designated by the Yellville-Summit Board of Education.
Unless prior arrangements are made, the Party of the Second Part shall sign and return Contract within 30 days of the date below. Contract shall be void if Party of the Second Part fails to present a valid Arkansas Teacher's Certificate to the School Board prior to the beginning of Contract. It is stipulated that Party of the Second Part shall make reasonable progress toward correcting deficiencies noted in the evaluation process. Should changes occur in either State law or funding, this Contract will be adjusted.
** Included in this contract's number of days are 4 days of approved professional development that must be earned before the time period covered by this contract begins.**


